Expected learning outcomes at the level of the course (3 to 10 learning outcomes)	 Describe and relate the role and importance of early Christian literature for the development of later Christian philosophy and theology and culture in general. To connect early Christian literature with Greco-Roman literature and its influence on the development of certain (national) types of literature, and its special influence on the development of theology. Distinguish between the historical and social circumstances of the creation of early Christian literature. List the most important editions of early Christian literature and assess their value and reliability. List the main information about the life, works and science of the most important representatives of early Christian literature, determine their peculiarities (chronological, geographical, ideological,). Explain and critically evaluate the main currents of thought of early Christian authors, especially in the field of literary genres and religious (theological) science. 						
2.5. Course content (syllabus)	In the introductory notes, along with the definition, terms related to Early Christian literature are explained. Basic information is provided on the languages in which early Christian literature was created and preserved, on the technology of writing and copying, and the time period in which it was created. The relationship of this literature to Jewish and pagan culture and other ancient literary traditions is also shown. More important (critical and non-critical) editions of early Christian literary works are also indicated. It gives an account of individual early Christian writers, their lives, titles and contents of their writings, grouped according to the time and (or) space in which they created. The goal of the course is to acquaint students with the richness and diversity of early Christian literature and its role in general culture and civilization. Through lectures, students are introduced to important topics, people and events from the period of early Christianity						

	(the first seven centuries) with an emphasis on literary works. The goal is also to acquaint students with the development of early Christian literature, the circumstances in which it was created, people and their writings.										
	The goals will be achieved by processing the following thematic units:										
	 Introductory remarks: patrology and patristics. Church fathers and early Christian writers. Division of early Christian literature. Christianity's relation to Jewish and pagan culture. Apostolic Fathers. Early Christian writers of the second century - apologists. Great Christian writers of the third century. Golden period of early Christian literature (4th and 5th centuries). Great Councils (Nicaea, Constantinople, Ephesus and Chalcedon). Augustine and Jerome. The time of decadence and the end of early Christian literature.
