Course Description

Course objectives are to indicate the scientific approach to the study of religions and to indicate the basic topics that religious sciences deal with. Course content: Introducing (specifics of primitive, polytheistic, dualistic, monistic and monotheistic religions; the significance of the common problems of the great traditional religions; reflections on religion through the prism of atheism and agnosticism). Thematic units: (1) Introduction to the religions of India (Hinduism; Jainism; Buddhism) (2) Religions of the Far East (Confucianism, Taoism, Lamaism, Shintoism) Contemporary monotheistic religions. (3) Origin and development of Judaism (Covenant; holidays; Torah; rites and customs). (4) Christianity (Origin and development of Christianity; Catholicism; Orthodoxy; Protestantism; Christian holidays; rites and customs (5) Islam (Origin and development of Islam; Islamic teaching; holidays, rites and customs; Main currents of Islam). (6) Religions of the world (Sikhism; African religions; American religions) (7) New religious movements (Origin and development; Systematization) (8) Ethics and morality (Introduction-ethics and religion; Specifics of Jewish, Christian and Islamic ethics; Decalogue; Lex talionis; The traditions of Abrahamic religions; (8) On religious community and belonging (Religion and nation; Religious communities and the state; Religion and politics; Religious freedoms in the system of human rights).

Logic

Course Description

Logic is one of the central instruments of methodical philosophical and other scientific thinking. The course Logic introduces a student to the theory and practice of argument evaluation through the principles of formal and informal logic and critical and creative thinking, with special emphasis on their application in the study of philosophy and religious sciences. Specifically, this includes understanding and recognizing arguments in everyday and scientific use, learning and understanding logical rules, the relationship between logic and natural language, writing in the language of propositional logic and using logical connectives, validating conclusions with truth table methods, reductio ad absurdum and truth trees, recognizing frequent logical errors, and the study of methods of successful argumentation.

Course Description

Teaching is performed in two modules: historical and problem-analysing. Historical module: 1) Introduction to the subject and historical part; 2) The dawn of metaphysics - pre-Socratics; 3) The main emphases of Parmenides and Heraclitus metaphysics; 4) Foundations of Plato's metaphysics; 5) Foundations of Aristotle's, metaphysics; 6) Comparison of Plato and Aristotle; 7) Metaphysics of Neoplatonism; 8) The main emphases and currents of medieval metaphysics; 9) Thomas Aquinas and scholastic metaphysics; 10) Metaphysics in the Renaissance; 11) Descartes, Pascal and modern metaphysics; 12) Leibniz's metaphysics; 13) Basic outlines of the metaphysics of classical German idealism; 14) Metaphysical systems of the 19th century; 15) Metaphysical foundations of existentialism and personalism; 15) Metaphysics of the postmodern era. Problem-analysing module: 1) Introduction to the module; 2) Clarification of the basic metaphysical concepts: (metaphysics, ontology, first philosophy, essence, being); 3) Possibility and justification of metaphysics, possible definitions; 4) The place of metaphysics in human cognition; 5) Metaphysical structure of being; 6) The analogy of being; 7) Transcendentals and the problem of universals; 8) The unity of being and the principle of identity and non-contradiction; 9) Categories of beings: substance and accidents; 10) Understanding the emergence (movement) and the principle of the

primacy of reality (about reality and possibility); 11) The problem of the subject (individual and person); 12) Action; 13) The principle of causality; 14) Causes; 15) Concluding discussion and evaluation.

History of Ancient Philosophy

Lecturer: Full professor Anto Gavrić

Course Description

Ancient philosophy covers the period from the origin of philosophy and science in Greece (6th - 5th centuries BC), through a deeper study of the philosophical systems of Plato and Aristotle, then follows the sequence of the main teachings of the Stoics, Epicureans, Skeptics and several important Neoplatonists until the closure of the philosophical school in Athens in 529.

Students are introduced to individual philosophical schools from that period by reading and interpreting key texts in a systematic way.

The objective is to show students how important ancient philosophy is for understanding the scientific culture of the West, how much it is present in the Christian thought of the first centuries, in medieval and Renaissance philosophy, and how much it is still a source of inspiration for modern philosophy.

The course consists of lectures and exercises in groups and aims to provide an introduction to a wide range of philosophical disciplines: logic, cosmology, natural history, physics, metaphysics, ethics, political philosophy, aesthetics, anthropology, etc.

The objectives of the course will be achieved through a chronological approach and treatment of thematic units, reading of original texts and critical discussions

The aim of this course is to be acquainted with the basic knowledge of the psychology of religion. Course content: 1. General introduction to the psychology of religion: Concept. Subject of study. Religiosity and faith. Spiritual exercises. 2. Psychological interpretation of religiosity: Methodical approach. Characteristics. Critical judgment. Notable authors. 3. Development of psychology of religion: The problem of stages. The roots of religiosity. 4. The role of the mother in the religious development of the child: Basic trust. Affective foundations of religiosity. 5. Childhood religiosity: anthropomorphism, animism. magical religion. A child's concept of God. 6. Religiosity of adolescents: Changes in religious opinion. Emotional aspects. Religion and morality. Religious doubt. Social dimension of religiosity. 7. Religious Maturity: The Function of Religious Attitude. Motivational autonomy. Characteristics of mature religiosity. 8. Psychopathology and religiosity: Various deviations in the psychological experience of religiosity. Religion and neurosis. 9. Parapsychological phenomena and real religiosity: spiritism, religious ecstasies 10. Psychological experience of mystical experience.

Elective Course in Ancient Philosophy: Philosophy as a Therapy of the Soul

Course Description

Concepts of philosophy have changed throughout history, and philosophy was generally considered a demanding discussion of abstract questions reserved only for experts. However, from antiquity to the present day, philosophy, in addition to being a teacher of wisdom, also carried the attributes of a doctor, comforter and therapist. Moreover, from antiquity until today, the philosophy is inseparable from medicine, but also from the most intimate part of the human being, and since antiquity it has been understood as an therapy of the soul. Such claims are supported by the texts of ancient philosophers (eg. Course Description

The course deals with the development of an aesthetics through the history of philosophy. The lectures follow a historical sequence, primarily for methodological reasons. Namely, analogous to the central idea of iconology developed in the first decades of the twentieth century by Aby Warburg and Erwin Panofsky, philosophical discussions of the problem of beauty and art are viewed primarily as an eminent expression of the culture and spirit of the time in which they originated. Students follow the presentations of the history of the aesthetic problems by reading and analyzing the most important pages of the literature on aesthetics of a particular period. In parallel with the study of the aesthetic problems in philosophy, selected works of art are analyzed in terms of the application of the newly studied theoretical principles in aesthetics. This element is an important component of the course insofar as it seeks to point out that aesthetic ideas are not merely abstract concepts that do not touch reality, but their application can be pointed out by analyzing some of the most important works of Western civilization. The course consists of lectures that include the mentioned presentations of the history of aesthetic problems and indicate their application to selected works of art.

The Middle Ages is a philosophically extremely important period from the 5th to the 15th century, rich in numerous debates, the study of which is necessary for understanding the development of philosophical thought, and thus for contemporary philosophical thematization. Namely, the confrontation between Greek rationality and Judeo-Christian and Islamic belief was reshaped by philosophical questioning, opening new horizons and new perspectives. The history of medieval philosophy studies the documents and writings that transmitted the thought of the Middle Ages and interprets their relationship with the cultural givens of that period, in order to make them more fruitful for a better understanding of the development of Western philosophy.

Course objectives: To show the influence of ancient philosophy and authors from the patristic period, a dialogically open philosophy in an interreligious context, to bring closer thinkers who created systems out of a great philosophical interest and can be considered representatives of the most important results achieved by the interaction between philosophy and theology: Augustine, Boethius, Pseudo-Dionysius the Areopagite, Anselm of Canterbury, Peter Abelard, Bernard of Clairvaux, Maimonides, Avicenna, Averroes, Albert the Great, Thomas Aquinas, Bonaventure, John Duns the Scots, Dante Alighieri, Meister Eckhart and William of Ocham. Provide an introduction to a wide range of philosophical disciplines: logic, cosmology, metaphysics, ethics, aesthetics, anthropology, political philosophy, etc. Lectures include processing of thematic units with a brief historical context, reading of original texts, critical discussions and work in groups.

To introduce the students to the most important schools and authors of the Middle Ages, the diversity of their learning and thinking about the most important philosophical topics, important concepts and definitions, the diversity of approaches and thinking, the importance of medieval philosophy for understanding the scientific culture of the West, and its relevance and significance for contemporary philosophical thematization.

This course aims to deepen the understanding of the human and Christian character of moral theology. Primarily it seeks to stress the distinctively human, i.e., ethical character of moral theology, the prime interest of which is man and his realization under the aspect of his free, i.e., human activity. With a clearer insight into the dimension of moral theology which is common to any other moral, or rather, ethical scientific discipline, we wish to stress its particular scientific interest at the moral level - human character. Aside from the specificity of moral theology, the seminar strives to point out also the singular Christian character of moral theology. This is done thorugh an underpinning in the moral teaching of three of the most prominent representatives of the great historical periods of Christian morality: the Apostle Paul (the Apostolic period), Aurelius Augustin (the Patristic period) and Thomas Aquinas (the Scholastic period) whose moral teaching comprises the historical substructure of our contemporary understanding of moral theology.

The purpose and goals of the course are achieved through several thematic (teaching) units that seek to achieve the conceptual comprehensiveness of the given topic. Thus, individual thematic units are covered with three main subtopics: (i) a historical overview of the concepts of religion and science, (ii) levels, i.e. perspectives of their relationship, and (iii) the state of the relationship in different world cultures with an emphasis on the Christendom. The first subtopic covers the following units: (i.1) the concepts of religion and science, (i.2) their state in the Middle Ages, and (i.3) religion and science in modern times. The second subtheme deals in more detail with their current relationship, focusing on individual considerations, and includes: (ii.1) inconsistency, (ii.2) mutual independence, (ii.3) possible dialogue, and (ii.4) proposed philosophical unification. The third subtopic includes: (iii.1) the relationship between religion and science in Christendom, (iii.2) a brief overview of the relationship between religion and science in predominantly non-Christian societies, and (iii.3) the survey results on the attitudes of scientists and the general public about religion and science. Also, if students want, the lecturer can organize a debate on a given topic, which deals with an individual thematic unit chosen by students. All students participate in the debate while the lecturer only observes and arbitrates if necessary.

The basic data from his life and the most important published works are briefly presented, and in more detail Patricius' main philosophical work Nova de universis philosophia (New Universal Philosophy). His philosophical system is elaborated in detail. Basic data about lives and writings is given about other Renaissance thinkers (Ivan Stojković, Benko Benković, Grgur Budisaljić, Juraj Dubrovčanin, Antun Medo, Marko Marulić, Faust Vrančić, Matija Vlačić). Other important Croatian philosophers such as Ruđer Bošković, Šimun Čučić, Bartol Kašić, Juraj Križanić and Andrija Dorotića, as well as the important representatives of the 19th and 20th century are also considered. Also, significant representatives of the Croatian Neo-Scholasticism are taken into research account, with the focus on the Jesuit thinkers.

A term culture etymologically indicates primarily a cultivation of the human spirit, body and society, while the subject of culture usually denotes a complex set of institutions, values, ideas and practices that make up the life of a particular human group and its individuals, and which are transmitted and received by learning. It originally referred to the material process of the colonization, worshiping, cultivation, and fertilization of the land, while through the historical interpretive evaluation it transgresses to knowledge, faith, religion, art, morality, laws, and customs.

Linking the nature and spirit, the civilization and society, as well as the necessity and freedom, the concept of culture throughout history dialectically oscillates among these couples, and through this course, students will be introduced to their degrees, segments and relationships within the indicated development path. In addition to a historical overview of the evaluation of the culture concept, the course will focus on the contemporary concepts and reflections, with an emphasis on evaluating the relationship of faith, knowledge and art as the mutually corresponding and eminently inseparable elements of the fundamental importance for the development of the spirit of the era, as well as of the human spirit per se.

Course objectives are to observe the history of Christianity, with special emphasis on periods and individuals who are significant for certain periods. In the introductory notes, along with the definition, terms related to Early Christian literature are explained. Basic information is provided on the languages in which early Christian literature was created and preserved, on the technology of writing and copying, and the time period in which it was created. The relationship of this literature to Jewish and pagan culture and other ancient literary traditions is also shown. More important (critical and non-critical) editions of early Christian literary works are also indicated. It gives an account of individual early Christian writers, their lives, titles and contents of their writings, grouped according to the time and (or) space in which they created.

The goal of the course is to acquaint students with the richness and diversity of early Christian literature and its role in general culture and civilization. Through lectures, students are introduced to important topics, people and events from the period of early Christianity (the first seven centuries) with an emphasis on literary works. The goal is also to acquaint students with the development of early Christian literature, the circumstances in which it was created, people and their writings.

Course Description

The purpose and goals of the course are achieved through several thematic (teaching) units that seek to achieve the conceptual comprehensiveness of the given topic. Thus, individual thematic units are united through two main sub-themes: (i) a historical overview of the development of biology as a science, and (ii) philosophical sub-domains and concepts in biology. The first subtopic includes the following teaching units: (i.1) biological thinking and research in the Old and Middle Ages, (i.2) biological reflections and research in the Renaissance and immediately thereafter, (i.3) biological thinking and research in the XIX century, and (i.4) biological thinking and research in the XX and XXI centuries. The second subtopic consists of the following teaching units: (ii.1) are there biological laws? (general theses of the philosophy of science such as "reductionism vs anti-reductionism" are viewed in a biological context), (ii.2) can conceptual (or theoretical) problems in biology be the subject of philosophical analysis? (ii.3) can thinkers (especially philosophers, but also other scientists) refer to biology when they think about traditional philosophical topics such as ethics and epistemology?

Theory of Evolution

Course Description

The purpose and goals of the course are achieved through several thematic (teaching) units that achieve conceptual comprehensiveness. Thus, the individual thematic units are grouped through two main subtopics: (i) *modes of biological evolution*, and (ii) *other themes in the philosophy of evolution*. Both subtopics cover several teaching units. The first subtopic seeks to describe the ways (mechanisms) through which evolution works, dealing with concepts such as *natural selection*, *sexual selection*, and *genetic drift*. The second subtopic reflects on the existing academic (sometimes very bitter) discussions that evolutionary biologists and philosophers of biology have with sociobiologists, evolutionary psychologists, and even the proponents of creationism. Furthermore, the second subtopic necessarily delves into a more detailed analysis of common dilemmas that are generally interesting in the philosophy of biology such as (i) replicator and transporter issues (instead of genes and organisms), or (ii) what exactly are the units and levels of natural selection or (iii) whether the genotype necessarily transmits some biological information and if so, in what exact sense, etc.

Elective Course in Christian Anthropology: Anthropological and Christian Character of Moral Theology

Course Description

This course aims to deepen the understanding of the human and Christian character of moral theology. Primarily it seeks to stress the distinctively human, i.e., ethical character of moral theology, the prime interest of which is man and his realization under the aspect of his free, i.e., human activity. With a clearer insight into the dimension of moral theology which is common to any other moral, or rather, ethical scientific discipline, we wish to stress its particular scientific interest at the moral level - human character. Aside from the specificity of moral theology, the seminar strives to point out also the singular Christian character of moral theology. This is done thorugh an underpinning in the moral teaching of three of the most prominent representatives of the great historical periods of Christian morality: the Apostle Paul (the Apostolic period), Aurelius Augustin (the Patristic period) and Thomas Aquinas (the Scholastic period) whose moral teaching comprises the historical substructure of our contemporary understanding of moral theology. The course consists of lectures (2 classes per week) which include five of the most important topics related to issues on the specificity of Christian morality as suggested by Servais Pinckaers in his most important work titled: The Sources of Christian Ethics. Lecture Content: the substance of moral theology; the difference between moral theology and other sciences; moral knowledge and positive knowledge; the comparison between the reflexive and positive methods; three dangers in the relationship between morality and other sciences; the difference between morality, art and technology; the quest for the human element; the problem of existence and the specificity of Christian morality; the analysis of a current response to the problem of Christian morality; the Christian morality of St. Paul; Christian morality in the Patristic period; Christian morality in the Scholastic period.

Also, we will critically evaluate the issue of the current environmental crisis.

Course Description

The purpose and goals of the course are achieved through several thematic (teaching) units that seek to achieve the conceptual comprehensiveness of the given topic. Thus, individual thematic units are covered with three main subtopics: (i) a historical overview of the concepts of religion and science, (ii) levels, i.e. perspectives of their relationship, and (iii) the state of the relationship in different world cultures with an emphasis on the Christendom. The first subtopic covers the following units: (i.1) the concepts of religion and science, (i.2) their state in the Middle Ages, and (i.3) religion and science in modern times. The second subtheme deals in more detail with their current relationship, focusing on individual considerations, and includes: (ii.1) inconsistency, (ii.2) mutual independence, (ii.3) possible dialogue, and (ii.4) proposed philosophical unification. The third subtopic includes: (iii.1) the relationship between religion and science in Christendom, (iii.2) a brief overview of the relationship between religion and science in predominantly non-Christian societies, and (iii.3) the survey results on the attitudes of scientists and the general public about religion and science. Also, if students want, the lecturer can organize a debate on a given topic, which deals with an individual thematic unit chosen by students. All students participate in the debate while the lecturer only observes and arbitrates if necessary.

The purpose and goals of the course are achieved through several thematic (teaching) units that achieve conceptual comprehensiveness. Thus, the individual thematic units are grouped through five main subthemes: (i) the historical discussion of mechanicists vs vitalists, (ii) the biochemical concept of the living matter, (iii) the scientific achievement of two fundamental Schrödinger's questions about the living matter: a) how order emerges from order again during genetic (i.e. vertical) continuity of the living matter?, and b) how the living matter from disorder creates order through metabolism during the homeostatic (i.e. horizontal) continuity?, (iv) the problem of the initial appearance of the living matter, and (v) the problem of "artificial" life. Each of the five subtopics includes one or more teaching units.
